**FJLEPC MEETING CALLED TO ORDER:**

**Public Communications:**

Trice Burgess reported that he has been in touch with the webmaster to update the FJLEPC website with the December 8, 2016, meeting minutes and is waiting hear back.

Vice Chairman Ranck reported he is looking into critical hazard facilities to do a tabletop exercise (not full scale) sometime next year, and will try and include real life events in the exercise.

Chairman Peterson attended the Citizen Corps Council's January 26, 2017 meeting. Work is ongoing to align how OEM can support the Council. Fairfax Alerts was discussed as well as the announcement that National Nightout will be August 1, 2017.

**Liaison with other LEPCs:**

Chairman Peterson attended most recent meeting. Recent incidents were discussed and there was a very good presentation by the Prince William County Health Dept. and George Mason University on Emergency Preparedness. The next meeting is March 20, 2017.

**Shelter in Place Video:**

Trice is working with Bob DeMarco with Fairfax County Channel 16 for the Shelter in Place video and FJLEPC.

**HAZMAT RESPONSE TEAM (HMRT) UPDATE**

**RECENT INCIDENTS**

Vice Chairman Ranck reported on two recent incidents:

- November 16, 2016 – ethanol tanker (8,000 gallons) dislodged from tractor on Terminal Road. No leaks were found.
- December 17, 2016 - during ice storm event, tanker (8,800 gallons) overturned on the Dulles Toll Rd. and Route 28. Upon response, tanker was found with wheels in the air and leaking fuel. Cleanup took 10 hours, with 6,700 gallons of fuel being pumped out and 2,000 gallons which leaked onto the road and nearby ground.

Cathy Roth had a question regarding cost recovery by Fairfax County for the tanker incident on Route 28. Rick Leino wanted to know if law enforcement agencies investigated incident. Vice Chairman Ranck responded yes and that the following agencies were there:

- Metropolitan Washington Airports Authority
- Virginia State Police
- Fairfax County Police
- Virginia Dept. of Transportation
- Virginia Dept. of Emergency Management

### **HMRT TRAINING**

Vice Chairman Ranck reported on team drills training held in February which included:

Police Dept (Narcotics) – drugs and chemicals that may be encountered

CIA Hammer Team – capabilities

FBI – capabilities and response option

DOD/Pentagon – good intel on chemical warfare

Cathy Roth also had a question on whether Fairfax County Hazmat was needed at the recent Covanta Fire. DC Barrero responded that Fire and Rescue personnel had been on the scene 24/7 for several weeks since the incident occurred. He indicated that updates may be available by the next meeting.

Trice Burgess reported he is temporarily handling the duties of the Tier II Manager until the position is filled permanently. He continues work on Tier II reporting. Invoices were sent out with a due date of March 1, 2017.
