**HAZMAT RESPONSE TEAM (HMRT) UPDATE**

**RECENT INCIDENTS**

Battalion Chief David Sellers reported there was a major gas leak/fire event on Hooes Road. Large hazardous materials and fire response. Leak was contained with 4 hours. Four persons injured but expected to make full recovery. There was a large media response. Regulatory agencies involved in investigation.

Event occurred recently in Reston involving person using laser cutter to cut plastics creating cyanide fumes. Investigation determined it event was accidental with no suspicious activity identified.
