**HAZMAT RESPONSE TEAM (HMRT) UPDATE**

**RECENT INCIDENTS**

BC David Sellers reported there have been natural gas leaks, propane leaks, and white powder calls. HMRT continues to monitor threats identified in our region; however, none have been identified in Fairfax County to date.

**HMRT TRAINING**

BC Sellers reported there will be training on handling with EBOLA, which is on the rise in certain parts of the African continent. Dulles Airport receives flights from these parts of Africa and is planning on handling EBOLA cases if they reach this area.

**Tier II Manager Update & HMERP**

- 573 – total active/inactive facilities
- 422 – active
- 161 – critical hazard facilities

98% active facilities have reported in, and Trice is working with the nine remaining facilities to bring them into compliance.
